Chief Secretary, Chairman, RMB welcoming the members and special invitees asked the Member Secretary, RMB to put up the proposal pending for consideration by the Board.

Ms. Sunita Narain, Member, RMB raised the issue of earlier minutes of RMB meeting held on 20<sup>th</sup> May, 2013 and observed that RMB has to reconsider the Army proposal regarding clearance for construction of infrastructure on army land in area adjacent to the Central Ridge Area taking into account issues like total land area under Defence authority adjacent to the Ridge Area and earlier land use pattern including constructions done in that area, etc. The user agency may be requested to place the detailed clarifications on the issues raised in the meeting for consideration in next meeting of the Board. In view of the above, the minutes of Board meeting held on 20<sup>th</sup> May, 2013 stand modified for agenda item-1, 'The proposed construction of infrastructure on Army land in area adjacent to the Central Ridge area' is still under consideration before the RMB.

Agenda item 1: Proposal for construction of 225 bedded Hospital at village Chattarpur (Mehrauli).

Mr. S.R. Sikka, Consultant of the construction project informed the Board about the need for the Hospital in this locality as the other nearest Govt. Hospital is approximately 10 Km away from the site and it would facilitate medical help to the people from Chattarpur, Mehrauli, Vasant Vihar and other nearby areas. The Hospital is to be constructed on Gram Sabha land on the fringe of the ridge forests. It has been proposed to follow Green Building norms and carry out extensive tree plantation within the site. Waste Management is also planned properly for the proposed Hospital.

Going through the details of the proposed construction of 225 bedded Hospital at Village Chattarpur (Mehrauli) it was noticed that the approach road to the site of proposed Hospital is passing through a very congested and built-up area. The approach road to the Hospital is also very narrow which may not be sufficient for movement of 3000-4000 people to the Hospital per day. It was also noticed that the proposed site is very near to the water body.

In view of these limitations, it was decided that DDA may be requested to submit a presentation before the Board on future development of the road and management plan to save the water body. The Chairman, RMB observed that forest area on the rearside and availability of water body near to the Hospital may improve the serenity of the Hospital. However, there should be a complete management plan for the nearby forest area and proper management of water body with its catchment area.

The meeting ended with vote of thanks to the Chair.
