No. F.16(6)/65-Lab.(ii).—In exercise of the powers conferred by section 5 of the Factories Act, 1948 (LXIII of 1948) read with the Notification of the Government of India, Ministry of Labour and Employment, No. S. O. 108 dated the 14th February, 1958, and in continuation of this Secretariat Notification of even number dated the 24th June, 1965, and to meet the public emergency in connection with the National Defence, the Chief Commissioner, Delhi, is pleased to exempt the factory known as Central Vehicle Depot, Delhi Cantt., from the provisions of sections 51, 52, 53, 54, 56 and 79 of the said Act, for a period of three months, with effect from 25th April 1965, subject to the conditions (i) that the leave may be refused where necessary in exigencies of service except in case of illness and leave may be accumulated without limits so that the workers do not lose the benefit of leave so refused and (ii) the workers who may be deprived of the weekly holidays provided in section 52 of the said Act, may be given as far as possible compensatory holidays in lieu of all such weekly holidays as may not be allowed to them.
